Explain or describe questions – definitions will need to be learnt for all topics			
Explain questions:			
make a point. give a reason why (ease)			
 give a reason why (case) state the consequence (positive or negative) for the legal system. 			
Discuss questions:			
Aim to use five connectives to build analysis chains in a discuss question. Examples of connectives are 'because', 'leading to', 'therefore', 'however', 'the consequence' and 'as a result'.			
Evaluate is the top-level skill that is assessed in A level Law exam. Evaluate questions look for respondents to form an opinion on a given issue and offer a critical response. Evaluate questions require respondents to use			
knowledge relating to the topic area and wider knowledge of Law to access the top-level marks. A conclusion is always necessary in an evaluate question.
